NOTE - NEW LAW: HB 1217 (2023, R.S) amended Section 85.005(c) of the Code, effective September 1, 2023, to require that in ALL counties (regardless of population), voting in a special election ordered by the Governor shall be conducted at the main early voting polling place for at least 12 consecutive hours on each of the last two days of the early voting period. Voting may not be conducted earlier than 8:00 AM or later than 10:00 PM. (Sec. 85.005(c)).


