- If you are requesting electric for a water well, irrigation pivot, etc. Septic is not required. Please indicate how many meters you are requesting from the Electric Company.
- Please provide Latitude and Longitude of your property this can help the process go by faster.
- If you are not the owner or leasing the property a letter from the owner will be needed in order to proceed the addressing portion.
