Along with your proposal of services and statement of qualifications, you must include the following:** Cost of Services: Infrastructure • Certification Regarding Lobbying • Disclosure of Lobbying Activities • System for Award Management – Consultant/Firm, and its Principals, may not be debarred or suspended nor otherwise on the Excluded Parties List System (EPLS) in the System for Award Management (SAM). Include verification that the company as well as the company’s principals are not listed (are not debarred) through the System for Award Management (www.SAM.gov). Enclose a print out of the search results that includes the record date and complete the Certification Regarding Debarment & Suspension and Other Responsibility Matters form. • Affidavit • Certificate of Interested Parties, Form 1295 – Must include when submitting your RFQ • Conflict of Interest Questionnaire, Form CIQ – Every vendor doing business with the County or seeking to do business with the County must complete Box 1 and sign and date in Box 7. Whether or not a conflict exists determines the other information to include on the form. • Copy of your current certificate of insurance for professional liability • House Bill 89 Verification
