Commissioner Quijas made a motion to leave executive session and enter into regular session at 10:49 am. Commissioner Moore seconded the motion. The motion passed.


Item #18-No action was taken was taken regarding the EEOC Complaint by Jesse Chavez, the item was a discussion item.
